ADOPTION OF THE SEAL OF THE PROFESSIONAL REGULATORY BOARD OF SPEECH LANGUAGE PATHOLOGY

WHEREAS, Republic Act No. 11249, also known as the “Speech Language Pathology Act”, was signed into law on March 22, 2019 regulating the Speech Language Pathology profession in the Philippines;

WHEREAS, Section 6 (d), Article II thereof empowers the Professional Regulatory Board of Speech Language Pathology (Board) to adopt its own seal which it shall use in all its official communications, issuances, and correspondence;

WHEREFORE, the Board pursuant thereto and upon consultation with the stakeholders, hereby adopts its seal as drawn and described below:



“The seal of the Board shall be circular in shape measuring 120 mm in diameter with an inner circle measuring 90.65 mm in diameter. The upper part of the annular shape bears the words Board of Speech Language Pathology while the lower part shows the words Professional Regulation Commission. The year that the Board of Speech Language Pathology was formed, on the other hand, is shown in the lower part of the inner circle.”

The images are a composite of meanings. The face symbolizes the clients or patients whom the profession aspires to unequivocally serve. The cogs or wheels stand for the key processes that shape language, speech, and communication as well as cognition. The ear underscores the importance of reception, perception, and understanding of information. Further, ideas that are conveyed through effective means of communication are encapsulated in the seal as phonetic symbols. The structure for swallowing embraces the profession’s role in improving a client or patient’s quality of life and survival.”

The muted colors likewise denote symbolism. The blue color connotes dependability and strength - qualities that speech language pathologists must strive to have. The color of sage implies growth. Growth within and among the professionals and ultimately, constant growth in the profession”

In the event that a part or parts of this Resolution are declared invalid, the remaining provisions not declared so shall remain effective.
