**APPROVAL OF APPLICATIONS FOR REGISTRATION WITHOUT
EXAMINATION AS MEDICAL LABORATORY TECHNICIANS**

WHEREAS, Section 21(3)¹ of Republic Act (R.A.) No. 5527, also known as the "Philippine Medical Technology Act of 1969", as amended, states that the Professional Regulatory Board of Medical Technology (Board) shall issue a certificate of registration as medical laboratory technician without examination, subject to compliance with the conditions therein prescribed;

WHEREAS, the Professional Regulation Commission (Commission) issued Memorandum Order No. 01 (s. 2020) on the "Revised Guidelines on Transmittal and Action of 'For the Board' (FTB) Application Documents from the Regional Offices";

WHEREAS, for consideration of the Board are the following applicants for registration without examination as Medical Laboratory Technicians in accordance with Section 21(3) of R.A. No. 5527, as amended:

WHEREAS, upon evaluation of the documentary requirements submitted in support of their applications, the Board finds that the above-named applicants have met all the qualifications set forth in the law.

WHEREFORE, the Board **RESOLVES**, as it is hereby **RESOLVED**, to allow the registration of the abovementioned applicants as Medical Laboratory Technicians in accordance with Section 21(3) of R.A. No. 5527, as amended. Upon approval hereof by the Commission and payment of the prescribed fees, let their Certificates of Registration and Professional Identification Cards be issued after they have taken the proper oath.

¹ Has failed to pass the board examination for medical technology but had obtained a general rating of at least 70%. Provided, finally, that a registered medical laboratory technician when employed in the government shall have the equivalent civil service eligibility not lower than second grade.
