**RESCHEDULING THE AERONAUTICAL ENGINEERS LICENSURE EXAMINATION
FROM NOVEMBER 15 - 17, 2022 TO DECEMBER 14 - 16, 2022 AND
EXTENDING THE DEADLINE FOR THE FILING OF APPLICATIONS
FROM OCTOBER 17, 2022 TO NOVEMBER 14, 2022**

WHEREAS, Section 7 (d) of Republic Act (RA) No. 8981 or the "PRC Modernization Act of 2000" empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate and to determine and fix the places and dates of examinations;

WHEREAS, the Commission issued Resolution No. 1439 (s. 2021) on the schedule of the licensure examinations for the calendar year 2022, including the opening of online processing, deadlines for filing of applications, practical examinations, target dates of release of examination results;

WHEREAS, pursuant to the abovementioned resolution, both the Geologists Licensure Examination (GLE) and the Aeronautical Engineers Licensure Examination (AELE) are scheduled on November 15, 16, and 17, 2022 and the deadline for the filing of application is on October 17, 2022;

WHEREAS, during a coordination meeting held last August 3, 2022, both the concerned Professional Regulatory Board (Boards) have decided to adopt the Computer-Based Licensure Examination (CBLE) System in the conduct of their respective licensure examinations for this year;

WHEREAS, considering that the conduct of the CBLE is in its early stage of implementation, all examinees in both licensure examinations cannot be accommodated, thus, the Professional Regulatory Board of Aeronautical Engineering (Board) agreed to move its licensure examination schedule from November to December;

WHEREAS, in order to preserve the integrity and maintain the orderly conduct of the licensure examination, the Board, the Licensure Office (LO), and the Licensure Division (LD) recommend the rescheduling of the AELE from November 2022 to December 2022;

WHEREFORE, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to **RESCHEDULE** the conduct of the **AERONAUTICAL ENGINEERS LICENSURE EXAMINATION** on **December 14, 15, and 16, 2022**.

RESOLVED FURTHER, that the deadline for the filing of applications for the December 2022 ALE shall be on **November 14, 2022**.

All Commission offices/divisions are enjoined to undertake the necessary coordination to ensure the smooth and orderly conduct of the licensure examination.
