**RECONSTITUTION OF THE CONTINUING PROFESSIONAL DEVELOPMENT COUNCIL
FOR DENTISTS, DENTAL HYGIENISTS AND DENTAL TECHNOLOGISTS**

WHEREAS, Republic Act (R.A.) No. 10912, otherwise known as the Continuing Professional Development (CPD) Act of 2016, institutionalized the CPD requirement for all of the regulated professions;

WHEREAS, the Professional Regulation Commission (Commission) issued Resolution No. 1032 (s. 2017) or the Implementing Rules and Regulations (IRR) of R.A. No. 10912 on February 15, 2017;

WHEREAS, Section 7 of R.A. No. 10912 and Section 7 of PRC Resolution No. 1032 (s. 2017), as amended, provided for the composition of the CPD Council, namely, the Chairperson from the Board concerned; First (1st) Member from the Accredited Professional Organization/Accredited Integrated Professional Organization (APO/AIPO); and Second (2nd) Member from the national organization of deans or department heads of schools, colleges or universities offering any course requiring the licensure examination;

WHEREAS, the Professional Regulatory Board of Dentistry (Board) issued Resolution No. 02 (s. 2020) creating the CPD Council for Dentists, Dental Hygienists and Dental Technologists and was reconstituted by virtue of Resolution No. 1322 (s. 2021);

WHEREAS, CARLITO D. PARAGAS, DMD, in his capacity as Officer-in-Charge of the Board, will assume the position of the Chairman of the CPD Council for Dentists, Dental Hygienists and Dental Technologists;

NOW THEREFORE, the Board **RESOLVES**, as it is hereby **RESOLVED**, to reconstitute the CPD Council for Dentists, Dental Hygienists and Dental Technologists by designating **CARLITO D. PARAGAS, DMD** as the Chairman of the CPD Council for Dentists, Dental Hygienists and Dental Technologists;

FURTHER RESOLVED, that the members of the CPD Council for Dentists, Dental Hygienists and Dental Technologists as reconstituted are as follows:

1. CARLITO D. PARAGAS, DMD	-	Chairman
2. AIMEE YANG-CO, DMD	-	First Member
3. ARTURO P. DE LEON, DMD	-	Second Member

They shall be directed to perform or exercise their powers and functions in accordance with Section 8 of R.A. 10912 and Section 8 of Resolution No. 1032 (s. 2017).

This Resolution shall take effect upon its approval.

Let a copy of this Resolution be furnished the Members of the CPD Council for Dentists, Dental Hygienists and Dental Technologists.
