**CHEMIST LICENSURE EXAMINATION
RESULTS RELEASED IN TWO (2) DAYS**

The Professional Regulation Commission (PRC) announces that **292** out of **642** passed the Chemist Licensure Examination given by the **Board of Chemistry** in **Manila** this **September 2012**.

The members of the Board of Chemistry are **Ms. Adoracion P. Resurreccion**, Chairman and **Ms. Soledad S. Castañeda**, Member.

The results were released in two (2) days after the last day of examination.

Registration for the issuance of Professional Identification Cards (ID) and Certificates of Registration will start on Wednesday, October 3, 2012 but not later than October 5, 2012. Those who will register are required to bring the following: duly accomplished Oath Form or Panunumpa ng Propesyonal, current Community Tax Certificate (cedula), 2 pieces passport size picture (colored with white background and complete nametag), 1 piece 1" x 1" picture (colored with white background and complete nametag), 2 sets of metered documentary stamps and 1 short brown envelope with name and profession and to pay the Initial Registration Fee of P600 and Annual Registration Fee of P450 for 2012-2015. **Successful examinees should personally register and sign in the Roster of Registered Professionals.**

The date and venue for the oathtaking ceremony of the new successful examinees in the said examination **WILL BE ANNOUNCED LATER.**
